I understand that these risks may result in serious personal injury, illness or death, even when all reasonable care and skill is exercised.

I acknowledge that I voluntarily choose to permit the student to participate in the Recreational Activity with knowledge of these risks and that some risks cannot be eliminated even with the exercise of due care and skill.
